

GOAL

I want to leverage and transmit the experiences that I gained in national and international work environments in senior management positions; corporate financial and economical management, integrated company management and related controlling systems - in the private sector. The design, implementation and supervision of Management Information System (MIS) is one of my key strengths.

MAIN ACHIEVEMENTS

- At **Kőröstej group** (4 production companies) I introduced SAP R/3 in a multi-company approach, including FI-CO, MM, PP, SD, SFP, AM, WM, BI modules and united NEXON system for wage and labour processes.
- I organized the company group's financial, accounting, tax, controlling SAP and NEXON activities under one service unite at one company (SSC). The SSC successfully managed the administration of 5 EU grant as well (1,9 Billion HUF).
- The consolidated turnover of the group increased from 6 Billion HUF to 24 Billion HUF while maintaining profitability, and the number of employees grew from 320 to 890 .
- The company group signed a strategic cooperation agreement with the Hungarian Government in 2014.

This happened without any significant credit loss to customers, applying American company management culture, controlling and reporting system.

- Application of SOX requirements at **Crown Group** in Hungary.
- Successful creation of a well-acknowledged customer credit control system supporting the commercial activities at Crown Group.
